

T&C for South Australia - WIN ULTIMATE FOODIE TRIP TO ADELAIDE Contest:

1. The Winner will be decided by random draw (Game of Chance) held on [15 October 2018] with ONE (1) Prize winner in total drawn. The Winner will be contacted by Tripoto via email using the contact address(es) submitted on the Winner's entry form. Where the Winner cannot be contacted by email after three attempts Tripoto will select another winner.
2. The Tripoto's decision is final, and no correspondence in relation to the Competition or the selection of the Winner will be entered into.
3. The Winner must state their desired travel dates within 1 weeks of notification of winning the Prize to ensure the maximum chance of availability of the Prize package. Proposed departure date and tickets are non-changeable once issued and are subject to the Block Out Periods referred to in clause 8 below.
4. Travel is on Singapore Airlines operated services only, seats are limited and are subject to availability at the time of reservation or ticket issuance. Valid for travel on Singapore Airlines in the designated class (W class) only. Both passengers must travel together on the entire itinerary.
